Chief, Sensitive Skills Branch, 2 AF/TTOC, Detachment 1 at JBSA-Lackland, Texas. Ms. Chauvin oversees an office of eight military, four civilians, and four contractors. She advises and assists the Det 1 commander on matters concerning the pre-screening and security clearance processing of more than 5000 Basic Training candidates in 25 Air Force specialties that require Top Secret clearances for technical training and future job performance. In addition, she advises on initial Personnel Reliability Program screening for Basic Trainees selected for nuclear mission performance. She also ensures 30,000 Basic Trainees have either a security clearance investigation started or completed prior to graduation.

Security Specialist, 502 Air Base Wing Information Protection, Joint Base San Antonio, Texas. Ms. Chauvin performed as the lead specialist for developing local security training, Industrial Security, and processing security incidents involving classified information for Air Force elements assigned to the San Antonio area, to include HQ AETC, AF Installation and Mission Support Center, 12th Flying Training Wing, 37 Training Wing, AF Personnel Center, AF Medical Operations Command, and others. She also was the Site Administrator for the Trusted Agent Verifications System which processed Common Access Card requests for contractors assigned to AF elements on JBSA.



Chief, Information Protection, 12th Flying Training Wing, Randolph AFB, TX. Ms. Chauvin oversaw an office of three civilians. She advised and assisted the 12 FTW Commander on matters concerning Information, Industrial, and Personnel Security functions. Her office performed security clearance actions for over 18,000 personnel assigned/attached to Randolph AFB, including HQ AETC, 19th AF, AF Audit Agency, and Air Force Personnel Center. She oversaw 56 unit Information Security accounts and performed annual program reviews to ensure units complied with Federal and regulatory requirements for the protection of classified materials. She also reviewed all contracts to ensure security requirements were adequately addressed and coordinated.
